G. Energy and Blue Growth Committee

The Energy and Blue Growth committee shall deal with:

- a) EU energy policy and initiatives of importance to ports related to the role of ports as energy hubs and the energy transition.
 - Relevant EU Energy Strategies such as the Hydrogen Strategy, Off Shore Energy Strategy, Blue Energy Strategy, etc.
 - Repower EU plan
 - Energy transition (energy as a commodity business development strategy)
 - EU Funding possibilities
 - TEN-E

In view of avoiding overlaps, environmental and climate related issues of energy policy shall be dealt with by the SD Committee.

b) Shall follow the EU policy and initiatives related to Blue Growth and shall assist the ESPO secretariat and the Ports active in the European Ports Form Subgroup on "Ports as hubs of Blue Growth" in the preparation and follow up of the meeting and work.



A. The Ferry and Cruise Port Policy network

The Ferry and Cruise Port Policy network shall bring together Cruise and Ferry port representatives and shall work in close cooperation with the other Cruise port organisations, as agreed in September 2014.

This network shall:

- Monitor the development of a code of practice for Cruise and Ferry Ports
- Report on policy issues being dealt with by ESPO's standing committees of importance for ferry and cruise business
- Monitor all cruise related EU initiatives such as Pan-European Cruise dialogue This network shall meet at least once a year. If needed, additional ad hoc meetings of the network will be organised. The existence of this network involving other cruise port organisations, does not prevent ESPO to organise, whenever relevant and necessary, additional internal meetings on ferry and cruise issues for ESPO members only.

B. Labour and Operations Network

The Labour and Operations Network is the Network where the work of the social Dialogue is being prepared. The secretariat assists the ESPO members that are represented in the Social Dialogue. The positions taken by the Network do not engage ESPO's full membership unless otherwise decided by ESPO's Executive Committee. The Labour and Operations Network meets in function of the agenda and decisions to be taken in the Social Dialogue.

C. The Legal Expert Group

The Legal Expert Group shall provide legal advice on demand of the Secretariat, responding to legal questions emanating from the General Assembly, Executive Committee or Technical Committees of ESPO.
